The University developed an Infectious Diseases Policy in 1995. This policy recently went through a consultation phase with the university's Joint Health and Safety Committees and was updated to reflect our current structure and needs. Occupational Health and Safety Services

Queen's University entered into an agreement with KGH mid 1997, to have the Occupational Health and Safety Department at KGH provide medical treatment for all Queen's employees working in departments or buildings involved in Biohazards work. The buildings covered by the agreement are: Botterell Hall, Bio Sciences Complex, Humphrey Hall, Etherington Hall, LaSalle Building, Richardson Laboratories, Syl and Molly Apps Wing, Physical and Health Education. The services provided by KGH include the following: assessing injured workers; providing first aid treatment as necessary; providing telephone advice as necessary; providing employee counselling as necessary in cases of needle stick injury or primate incident; dispensing of any mandatory vaccinations; and for employees of Animal Care Services, annual tuberculosis skin testing and annual testing for rabies antibody.

Staff from any of the laboratories requiring these services are to directly go to KGH Occupational Health and Safety Department located in Watkins 1, KGH between the hours of 8 am and 4 pm, Monday to Friday. If an emergency occurs after hours or on weekends, staff are to report to KGH Emergency. When accessing these services, please have staff indicate that they are Queen's University employees and that they have been working in a laboratory with Biohazards present. Departments will be charged back any of the costs incurred when accessing these services. A monthly invoice is sent to Environmental Health and Safety, who in turn will inform the departments of the costs.

the end of July, all faculty and staff workstations should be running with at least 64 Mb of RAM, at least 2 Gb of Hard Drive space and at least Pentium 166 Mhz processors.

Of the 39 workstations receiving the voice dictation/transcription stations, all but 15 have been installed. Those 15 kits were backordered and still have not arrived.

Workstation Software Upgrades:

Netscape is up to v4.61 and is installed whenever I come around for any kind of maintenance.

Dr. Solomon antivirus scanner is up to v7.96 and is also upgraded whenever I come around.

If you are looking for this or any other software in use in the department, it is now fairly permanently located on the machine CDSERVER1, in the directory software, or in other terms: \\cdserver1\software You can find it by going from your desktop to network neighbourhood to CDSERVER1 to software.

Internet Explorer v3, 4 and 5 are also available but they tend to radically chance the look and feel of your computer system.

File Server Richlab1:

This machine was upgraded in mid une and with 1 exception has been fairly/relatively stable.


ADSM Backup Service:

A recent audit showed that of the 67 odd machines in the department only 34 have the ADSM backup service. This was mainly due to historical costs \$75. In addition all new and existing ADSM clients that use more than 3 Gb of space will be charged for the extra space (effective September 1st). This will turn out to be an accounting nightmare (especially as I suspect it will be billed on the peak use, not average use).

One proposal that I am looking at for those with ADSM and more than 3 Gb of files, is to only backup the data, and not the operating system our programs that I normally install (windows nt, service packs, telnet, netscape, email, corel office, etc). Restoring these typically doesn't work efficiently at all and is more of a pain in the butt than it is worth.

For those with more than 3 Gb of data, I'm not sure what to do at this time. Stay tuned.

For those without ADSM, the only way now available to backup your data (normally on a drive all by itself) is to copy it to an Iomega Zip Disk (100 Mb), or to create a CDROM (650 Mb).



A reminder to log off or shutdown when you leave for the end of the day. In order to perform a complete Backup of the File Server, the system needs to have all programs and data files closed. In the past this has often failed due to people being logged on in the early morning hours.

Starting tonight (May 17th) all users will be forced off the system at 00:00 and will not be allowed back on until 03:00 (much like the days before 1998 August with the Netware server). This will help to create better and more reliable backups.

If you are logged on at this time and running programs (ontime, pegasus mail), they may fail because of the forced disconnect and in the morning you will see error messages and be forced to restart those programs.

You will receive warning messages just before and again at midnight.
